NOTES OF EXPLANATION:

* As a club that is a member in good standing with the OCA (Ontario Curling Association), we collect dues that are paid to the OCA annually. These fees are charged to each club that is a member of the OCA, and entitles members of our club to enter OCA sanctioned events on behalf of the Ayr Curling Club. The Capital Improvement charge is a necessary levy to ensure the future sustainability of the club. This \$50 charge per member is placed into a separate bank account at the start of the season. Currently, the club has a strategic planning committee that is responsible for short-mid-long term planning for any capital expenditures. Recent examples of improvements funded partially or completely by the Cap Imp Fund are:

- Replacement of the ice surface lighting system (2010)
- Replacement of the ice floor brine lines & addition of XPS insulation (2012)
- Replacement of on ice heater units (2014)
- Replacement of Exterior Emergency Doors and Exterior lighting converted to LED

** The Open Choose-Your-Own (competitive) league plays on Wednesday evenings, as well as Tuesday at 9pm (depending on the number of teams registered). This season, each player from a CYO team that is registering **must** add the names of all players on that team to their form. Additionally, all membership forms and payment for all team members must be received by the end of registration night (Sept 16) in order to guarantee entry to the league
